The Department of Justice, Lands and Survey and Community Services hereby informs the public that the Court of Appeal of Niue and the High Court of Niue shall be convened in the month of March 2019.

Chief Justice Craig Coxhead, Judge Wilson Isaac, Judge Sarah Reeves and newly appointed Judge Miharo Armstrong will all arrive in Niue on Friday 8 March 2019 to preside in these Courts.

The Court Sittings are scheduled to be held on the week starting from Friday 8 to Friday 15 March 2019.

The Court Sittings will be held at the Conference Room of the Niue Public Service Building and the Niue Golf and Sports Club at Fonuakula, Alofi.

The Department will provide further confirmation of the exact dates and times of the sittings as well as court schedules and listings when these are finalized.

To all applicants or persons intending to file applications in the Court of Appeal of Niue or the High Court of Niue in March 2019 please take note of the following matters:

- The last day for receiving and registering all completed applications for the March 2019 Sittings is Thursday 24<sup>th</sup> January 2019 before 4.00pm.
- Only those applications which are completed in full or those applications which are pending and have been directed by the Courts to be listed for hearing will be permitted on the Court lists for Hearing in March 2019.

- All applications must be registered with the Registrar of the High Court at the Department of Justice at Fonuakula, Alofi and only during office hours.
