- Voting in advance will be held at the **Department of Justice, Lands, survey and Community Services at Fonuakula, Alofi** on **Monday 29 September 2025 from 9am to 1pm.**
- **Only those voters who are confirmed to travel out by plane to New Zealand on Monday 29 September 2025 can vote in advance.**
- Voters must complete an application form and submit to Deputy Chief Electoral Officer Richard Siataga before 1pm on voting in advance day to be able to vote in advance
- Voters must attach a copy of their e-ticket or boarding to the application or show evidence confirming travel to the Deputy Chief Electoral Officer.
