7.1 Mr Speaker, I move as a matter of priority, for this Assembly to call on the Government, to look at amending the 1991 Pensions and Benefit Act, to allow those who qualify in receiving the Niue Pension, to continue receiving their Pension entitlement in New Zealand after 6 months, more so those who are terminally ill and are unable to return back home to Niue. This, is particularly important as they also do not meet the criteria for receiving the NZ pension or any other benefit as they have not resided or worked in NZ for 10 years.
